Dear Parent or Guardian,

Your household may be eligible to receive Pandemic Electronic Benefit Transfer (P-EBT) benefits to buy food. P-EBT is for children 5-18 years old who received SNAP food benefits for the month of March 2020 and children up to 21 years old who are certified for free or reduced-price meals at school in Texas during the 2019-20 school year. Children that attend a school that offers free meals to all students (Community Eligibility Provision or Provision 2) are also eligible.

The online application for P-EBT is now open. Please review the criteria to see if you need to apply to receive these benefits. The application link is provided below.

Do I need to apply for P-EBT?

Families that DID NOT get SNAP benefits for the month of March 2020

- Yes, you will need to apply.
- Fill out an application here: yourtexasbenefits.com/Learn/PEBT
- The application is open until June 30, 2020.
- If you do not currently get SNAP benefits and your child is approved for P-EBT, you will be mailed a P-EBT card loaded with benefits.

Families that DID get SNAP benefits for the month of March 2020

- You do not need to apply for children ages 5-18. Benefits were loaded onto your existing SNAP card by May 22.
- If you have children under 5 and/or between the ages of 19 and 21, you will need to fill out an application for those children. Fill out an application here: yourtexasbenefits.com/Learn/PEBT
- If you get SNAP benefits and your child is approved for P-EBT, we will put funds on your current Lone Star Card.

P-EBT is a one-time benefit for families issued through an EBT card (like a debit card). Families receive up to \$285 per eligible child. You will have one year from the date the benefits were issued to use your P-EBT benefits. P-EBT benefits are non-transferrable.

Su familia podría calificar para recibir la Transferencia Electrónica de Beneficios durante la Pandemia (P-EBT, por sus siglas en inglés) para comprar alimentos. P-EBT es para niños de 5-18 años que recibieron beneficios de alimento SNAP para el mes de marzo de 2020 y para los niños de hasta 21 años que calificaron para las comidas gratuitas o de precio reducido en una escuela en Texas durante el año escolar 2019-2020. Los niños que asisten a una escuela que ofrece comidas gratuitas a todos los estudiantes (Provisión de elegibilidad comunitaria o Provisión 2) también califican.

La solicitud en línea para P-EBT está abierta ahora. Por favor revise los criterios para ver si necesita solicitar para recibir estos beneficios. El enlace de solicitud se proporciona a continuación.

¿Tengo que enviar una solicitud para P-EBT?

Las familias que NO recibieron beneficios SNAP para el mes de marzo de 2020

- Sí, tienen que enviar una solicitud.

- La solicitud está abierta hasta el 30 de junio de 2020.
- Si actualmente no recibe beneficios SNAP y su hijo califica para P-EBT, recibirá una tarjeta de P-EBT por correo postal con los beneficios.

Las familias que SÍ recibieron beneficios SNAP para el mes de marzo de 2020

- No tienen que enviar una solicitud para los niños de 5 a 18 años. Los beneficios se agregaron a su tarjeta SNAP existente para el 22 de mayo.
- Si tiene hijos de menos de 5 años y/o entre 19 y 21 años, tendrá que completar una solicitud para esos niños. Complete su solicitud aquí: yourtexasbenefits.com/Learn/PEBT
- Su usted recibe beneficios SNAP y su hijo está aprobado para P-EBT, agregaremos fondos a su tarjeta actual Lone Star.

P-EBT es un beneficio de una sola vez para las familias que se emite por medio de una tarjeta EBT (como una tarjeta de débito). Las familias reciben hasta \$285 por niño que califica. Tendrá un año desde la fecha que se emitan los beneficios para usar sus beneficios P-EBT. Los beneficios de P-EBT no son transferibles.
